

# **Dental School Moves Forward With Plans for New Facilities**

## University of the Pacific Regents Approve Plans Following Feasibility Study from the School Community

University of the Pacific's Board of Regents recently approved plans for the dental school to continue to move forward with exploring new facilities in San Francisco. This decision comes on the heels of a compre-



hensive facilities programming study, initiated as part of the school's strategic plan, that analyzed the size and type of space the school will require for decades to come.

The school hired Kahler Slater, an interdisciplinary design firm with extensive experience working with healthcare facilities and dental schools, to conduct the study between July and November 2010. Input was gathered from working groups involving students, faculty, staff and alumni on areas including learning environments and classrooms, clinics, offices/administration, technology and communal spaces.

Some of the drivers identified through the school's planning process include flexible learning spaces to support recent changes in the cur-

riculum; smaller, group practice-style clinical environments to support patient care and education; communal spaces for the school community; location to public transportation; and efficient, sustainable features to meet modern facility standards, among others.

The programming project was overseen by a core committee that included members of the University and dental school administration, as well as representatives from the school's Alumni Association and Pacific Dugoni Foundation.

"Our focus on facilities will ensure that the school will remain on the forefront of dental education worldwide," said Dr. Patrick J. Ferrillo, Jr., dean of the Arthur A. Dugoni School of Dentistry. "We are committed to building and maintaining our top-notch people and quality programs, and now we have the opportunity to move ahead in planning for world-class facilities to match."
