Lou was one of my co-authors on [Global Issues in Contract Law](#) ("GICL"), and a beloved friend and colleague for all of us. He was the

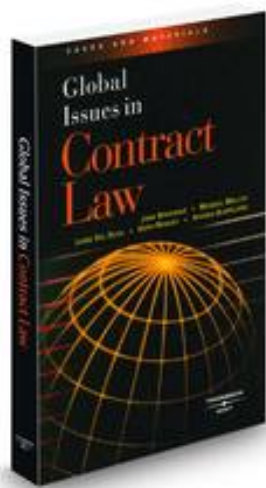



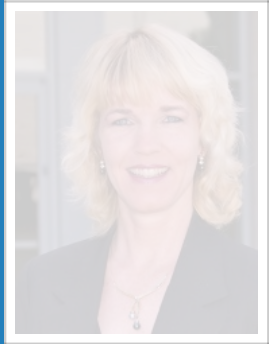
