**"THE PEOPLE KNOW WHAT THE GOVERNMENT WANTS: THE PROBLEM IS
THAT THE GOVERNMENT DOESN'T KNOW WHAT THE PEOPLE WANT"**

Senator George R. Moscone

Senator George Moscone wants to find out what the people of the State of California want from government. There is no better way to know what the people want than to meet with them personally.

To meet Californians, George Moscone is embarking on the most extensive tour ever made by a public official in this State. From the Oregon border in the north to San Ysidro in the South, George Moscone plans to meet and talk with Californians about their problems and needs.

As a public official George Moscone has carried government to the people, and the people's opinions and needs back to government. Here's how he did it:

- After hearing people's complaints of the high cost of medical treatment, George Moscone introduced his Consumer Health Protection Act which provides for inexpensive and comprehensive health coverage for all Californians.
- In 1972 when George Moscone learned that consumers had to pay for auto repairs resulting from a manufacturer's recall notice, he passed a bill forcing the manufacturers to pay for the repairs.
- When Proposition 1 threatened to drastically raise property taxes, George Moscone traveled throughout the State to explain the significance of this proposition to homeowners and renters.
- When George Moscone heard that the State subsidies for the aged, blind and disabled were going to be cut, he initiated legislation to assure that these people were not reduced to starvation incomes.
- When George Moscone visited Indians and saw a need for schools and health services, he introduced legislation which would establish education centers and provide health services in the Indian communities.
- After seeing some of the State's 500,000 hungry and malnourished children, George Moscone introduced legislation to feed preschool children and to provide free or reduced priced lunches in California's elementary schools.

Watergate and other recent events have eroded public trust and confidence in all levels of government. George Moscone believes our system cannot afford public officials who are above accountability to the public.

As **Governor**, George Moscone will hold twice-a-month public meetings in which everyone will be asked to express ideas and criticisms. The public meetings will be held in cities and towns across the State to accommodate people outside Sacramento. He will also provide a **free hot line** direct to a special ombudsman in the Governor's office.

As a candidate and as Governor, George Moscone needs your help to return government to the people!
