## **Our Commitment to Every Student**

To the university community:

As the inauguration of President-elect Trump draws near, many Pacificans have expressed concern that the new president may take actions consistent with his campaign promises to immediately overturn President Obama's executive orders and deport undocumented immigrants.

President-elect Trump may choose to end DACA (Deferred Action for Childhood Arrivals), an executive order issued by President Obama in 2012 that allows eligible undocumented immigrants to have a work permit, attend college, and be protected from deportation for a renewable, two-year period. There is also apprehension that harsh restrictions will be imposed on international students and possibly Muslims, and/or that federal authorities will expect colleges and universities to actively enforce immigration law. I firmly believe that our students' immigration status and/or their religion should never affect their ability to access and benefit from a Pacific education. I want to assure you that University of the Pacific remains steadfastly committed to the well-being of all our students regardless of their immigration status or their religious background. We will continue to provide a respectful, safe and inclusive environment and continue to embrace the intellectual freedom, religious freedom, and freedom of expression that are the hallmarks of being a Pacifican. Consistent with our mission, our principles and our values, we commit to the following:

- The university will continue to welcome applications to its programs from qualified applicants who are undocumented, including those who have DACA immigration status or who are DACA-eligible. If DACA is revoked, we will expand financial assistance to impacted students. In addition, we will continue our practice of making financial aid available to undocumented students from private or public sources legally available to them from the State of California.
- If the university receives requests for information that implicate individual privacy rights, it will work closely with the Office of General Counsel to protect the privacy of those members of the community in compliance with federal and state student privacy laws. We will not release immigration status or related information in confidential student records to federal agencies or other parties without permission from a student, or without a judicial warrant, a subpoena, a court order or as otherwise required by law.
- University of the Pacific campus public safety officers are here to protect our students and the university community. Officers will not contact, detain, question or arrest an individual solely on the basis of suspected immigration status or to discover the immigration status of an individual. University police will not detain an individual in response to an immigration

hold request from ICE (U.S. Immigration and Customs Enforcement), or any other law enforcement agency enforcing the immigration laws, unless doing so is required by law.

- The university does not tolerate acts of discrimination or harassment against members of its community based on their citizenship or immigration status, religion or other status. The university protects free expression of ideas as vital learning in an educational setting. Freedom of speech sometimes protects controversial ideas and sometimes protects even perceived offensive and hurtful language; however, it does not protect personal threats, discriminatory conduct or other acts of misconduct that violate the Student Code of Conduct, university policies, or federal, state and local laws.
- The university will not cooperate with any federal effort to create a registry of individuals based on any protected characteristics such as religion, national origin, race or sexual orientation.
- The people of our institution and our larger community benefit from the talent and expertise of our faculty. We are grateful that our faculty members versed in immigration law and the constitutional rights of individuals will be strong voices on our campuses, in our communities and on the national stage. We will provide information through websites, panel discussions and legal clinics. Look for announcements in the *Pacific Insider* and on our DREAMer, DACA and Undocumented Student Resources webpage.

In support of our students and all college students, we will seek to influence federal policies and actions. For example, shortly after the election, I joined more than 600 university presidents across the nation in a petition urging the incoming administration to continue to honor the promises of DACA. We note the "critical benefits of this program for our students, and the highly positive impacts on our institutions and communities," and cite its continuance as a "moral imperative and a national necessity." This petition is more than words-it is already impacting actions on Capitol Hill. For similar reasons, I have accepted the nomination to serve on the governing board of the National Association of Independent Colleges and Universities (NAICU), because doing so will allow me to understand, influence and advocate for federal policies and actions that are consistent with Pacific's commitment to diversity and the inclusion of all students. Through this important organization, our collective voices can powerfully advocate for justice and fairness and allow us to be true to our values and our commitment to students. We don't know yet what will come with the new administration. We do know that our work today is more important than ever and we will continue to stand together. By fostering mutual respect, engaging in difficult dialogue, and caring for one another in these uncertain times, we will become not only a stronger organization, but a powerful force that makes the world a better place.

I am reminded yet again why I am proud to be President of this exceptional university.
