

#### Subscription Information & Requests For Back Issues

No single issue subscriptions are available; however, single issues may be purchased independently of a subscription. The Review of Selected Nevada Legislation is published biennially and can be purchased for \$16.00 per issue.

Requests for the Journal should be in writing; telephone orders will be taken only if paid for prior to mailing. A subscription will commence with each October issue and billing will occur within that month. Statements will be sent quarterly through July, at which time an account must be current to insure mailing of the next volume.
